The aim of this new quality improvement training programme is to improve knowledge, skills and understanding in care for people with dementia nearing the end of life, to enable a 'gold standard' of care. A key focus of the programme will be to enable people to live and die well at home/care home in line with a campaign to reduce avoidable hospitalisation for people with dementia, to improve assessment of pain and to enable more to have earlier advance care planning discussions.

- The 4 key areas are to...**
- Improving awareness of care for people with dementia, the national context and the importance of dignity and respect.
 - Improving understanding and assessment of symptoms especially pain, distress and symptom management
 - Improving uptake of advance care planning and best interest discussions and support for carers
 - Enabling more to live and die at home and reducing avoidable hospitalisation

- Who will find this useful?**
- Anyone involved in care for people with dementia e.g. GPs, District Nurses, practice nurses and others in primary care teams
 - Care home staff - nursing and residential, care assistants and others
 - Hospital staff - acute and community
 - Domiciliary care workers
 - Volunteers, clergy and others

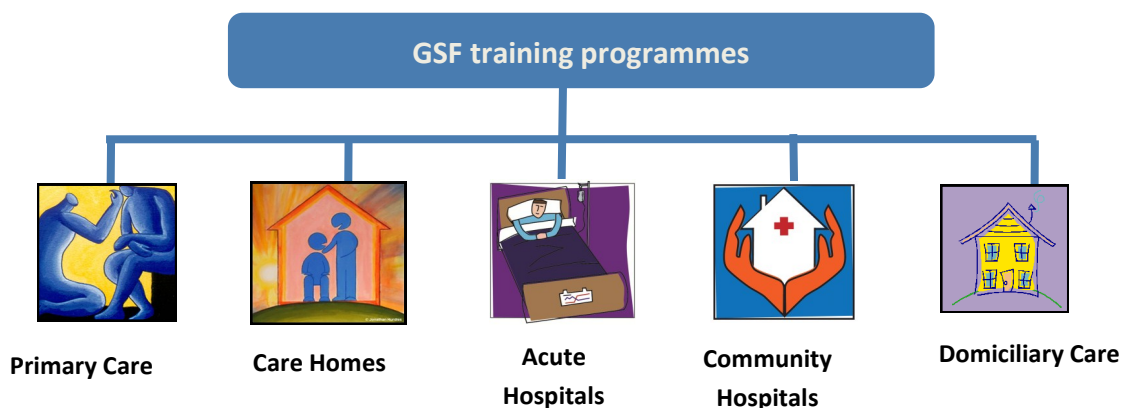
How does the GSF Training Programmes Help?
