This one day intense workshop will demonstrate ways of improving care for your most vulnerable patients to make the most of the DES whilst providing top quality care - best care for your sickest patients.



This step by step approach will embed real improvements in the care for your most vulnerable patients, helping you achieve the DES targets by:-

- Identifying vulnerable patients early
- Recording advance care planning discussions
- Improving collaboration with care homes
- Avoiding unplanned admissions

This is a great opportunity to improve end of life care in your practice, supporting you to achieve the DES.






Delivering best care for your patients most in needusing GSF Principles of 'Identify, Assess, Plan' to help you achieve your DES and improve care for vulnerable patients


GSF can help you with the BMA Step-by-step guide

- Establish the case management register
- Inform patients + put care plans in place
- Offer a bypass number + same day access
- Contact patient following discharge
- Review care home emergency admissions and A&E attendances
- Review register unplanned admissions

What the workshop will include -guidance, teaching and practical examples to help you:

- Identify—early preparation
 - Identifying 2% of the population patients for your register and use of PIG, PIGLET and e-PIG tools
 - Using GSF needs based coding—the 'blue' category and effective multidisciplinary team meetings
- Assess—better listening
 - Advance Care Planning discussions to seek patients' wishes and preferences 'Thinking Ahead',
 - Informing patients and communicate these wishes to others involved in care eg locality register or EPaCCS,
- Plan-to reduce crises
 - Fast tracking patients and carers for same day response within the practice, central contact to 24/7 support to reduce emergency/111 calls,
 - Collaborate well with care homes to reduce emergency admissions through proactive planning and better working together. Examples of significant results in reducing unplanned admissions for residents.

The Full GSF Going for Gold Training—If you wish to progress to the full practice-based Going for Gold programme for use with your whole team, (leading to GSF RCGP Accreditation) there is a special reduction of £100 for those attending the workshop and registering for the programme —packs can be pre-ordered for collection on the day.
