Dear Colleague,

The GSF Centre in End of Life Care has for over a decade been the leading provider of training in end of life care to generalist frontline health and social care professionals in the UK. We focus on population-based End of life care, upskilling generalists through change management and system-thinking, embedding self-sustaining practical changes to meet the challenge of our aging population. This complements the work that you and others provide in specialist palliative and end of life care, and together we can have a real impact on a wide population of people in a local area. This broadening of approach to meet changing needs and future challenges is also in line with the recent Help the Hospice Review, developing the work and reach of hospices for the future.

We would like to invite you to become part of our work. Over the last 6 years we have been working with 8 Regional Centres, 5 of which are hospices, with St Christopher's Hospice London being the first. These partnerships have proved extremely exciting, synergistic and fruitful, with fantastic developments happening in these areas. For example, one hospice successfully secured a local LETB grant to help train over 80 care homes, 76 GP practices, hundreds of domiciliary care workers and support GSF in the local hospital. Others are cross boundary care centres and others have trained all care homes in their area, with a great impact on their ongoing support and education. Most find that following GSF training there is a significant increase in uptake of hospice educational programmes, and better collaboration with community teams, to improve end of life care in a wide local area. So national GSF programmes plus local hospice implementation appear to be a good combination fir the future.

Your invitation to apply. We are now looking to establish a further four GSF Regional Centres ready for 2015. So:


- If you are, or aspire to be a centre of excellence in your area for education in end of life care
